### \*SUBJECT TO CHANGE

Cost of Attendance (COA) for a student is defined as an estimate of that student's educational expenses for the period of enrollment. The COA may include tuition and fees, books and supplies, costs of obtaining a license, certification, or first professional certification, federal student loan fees, food and housing, miscellaneous and personal expenses, and transportation. ### **ADDITIONAL INFORMATION**

- Students who have additional extenuating need such as, but not limited to, cost of a computer/electronics, child care expense, change in living status (with parent to off campus), additional fees/kits/supplies/books based on program or specific class may request a Cost of Attendance (COA) adjustment evaluation. COA adjustment evaluations may be approved or denied and require documentation.
- Tuition hours are calculated as follows: 4 month = 15 credit hours, 9 month = 30 credit hours, 3 month = 6 credit hours, 12 month = 36 credit hours
  - **In State Tuition** = \$170.00 per credit hour + \$5.00 one-time per semester access fee
  - **Out of State Tuition** = \$299.00 per credit hour + \$5.00 one-time per semester access fee
- Students who enroll in less than the calculated tuition hours will be have a COA recalculation based on degree program credit hours actually attended each semester up to 15 hours.
- Direct Loan Fees are an average from 2022-2023 of what was paid for the Fall and Spring. \$24.00 Fall/Spring
- 3 MTH = 3 Month Summer; 4 MTH = 4 Month - Fall OR Spring Term; 9 MTH = 9 Month - Fall and Spring Terms; 12 MTH = 12 Month - Fall, Spring, and Summer Terms
- 4 MTH is half of 9 MTH COA Room & Board, Direct Loan Fees, Transportation, & Miscellaneous/Personal
- Average fees by program include course fees charged to the student's account by course and fees that a student may incur while enrolled at CACC that are not charged to the student account.
